The Board of Environmental Safety (Board) provides this letter to inform you that the period for filing a motion to augment or strike the administrative record in this matter has closed.

On May 1, 2023, Lighting Resources, LLC, a California limited liability company (Permittee) refiled an appeal concerning DTSC's June 30, 2022 final decision on the Standardized Hazardous Waste Facility Permit (2021/22-HWM-11) issued to the Permittee. On June 8, 2023, DTSC's Permitting Division submitted an electronic copy of the administrative record consisting of the set of documents relied on to issue the draft and final permit, pursuant to Title 22, California Code of Regulations, Sections 66271.8 and 66271.17. The Board made the administrative record available to the Permittee and to members of the public that requested a copy.

After receiving the administrative record from DTSC's Permitting Division, the Board provided a period of thirty (30) days in which to file a motion to augment or strike the administrative record. Having received no such motion, the Board hereby deems the administrative record in this matter to be certified.
