CONTROL'S JOINT STIPULATION RE:  
PETITION ISSUES #24 AND #30

**JOINT STIPULATION**

Appellant Lighting Resources, LLC ("LRL") and Appellee California Department of Toxic Substances Control ("DTSC") hereby agree to the terms of this Joint Stipulation.

On June 30, 2022, DTSC issued Hazardous Waste Facility Permit No. 2021/22-HWM-11 ("Permit") for LRL's facility located at 805 East Francis Street, Ontario, California 91761. On May 1, 2023, LRL filed a petition for review of DTSC's permit decision with the Board of Environmental Safety ("BES"). The hearing on LRL's petition is set for January 17, 2024, in Ontario, California.

IT IS HEREBY STIPULATED and agreed by the parties that:

**Issue #24 - Revisions to Special Condition No. 1, Part V**

1. LRL agrees to submit a Class 1\* permit modification, following the procedures set forth in Section 66270.42 of Title 22, Div. 4.5 of the California Code of Regulations (“CCR”), to modify Special Condition No. 1 (Part V) of the Permit to read as follows:

“The Permittee shall not make any changes to the facility that require a permit modification, as set forth in Sections 66270.42 and 66270.42.5 of Title 22 of the California Code of Regulations, prior to (1) notifying DTSC, (2) processing a permit modification with DTSC, and (3) if required by the aforementioned regulations, receiving DTSC’s approval of the permit modification.”

2. Upon LRL’s completion of all the Class 1 modification procedures set forth in 22 CCR Section 66270.42, DTSC agrees to modify Special Condition No. 1 (Part V) of the Permit to match the language in Paragraph 1 of this Stipulation.

**Issue #30 - Revisions to Special Condition No. 29, Part V**

3. LRL agrees to submit a Class 1\* permit modification, following the procedures set forth in Section 66270.42 of Title 22, Div. 4.5 of the California Code of Regulations, to modify Special Condition No. 29 (Part V) of the Permit to read as follows:

“The Permittee shall take reasonable efforts to notify truck drivers transporting universal waste or hazardous waste to or from the Facility that the preferred route is to avoid transportation along the section of Francis St. between Euclid Ave. and Campus Ave. past Sultana Elementary School.”

4. Upon LRL’s completion of all the Class 1 modification procedures set forth in 22 CCR Section 66270.42, DTSC agrees to modify Special Condition No. 29 (Part V) of the Permit to match the language in Paragraph 3 of this Stipulation.

**Withdrawal of Issues #24 and #30 of LRL’s Appeal**

5. LRL agrees that it shall withdraw its appeal of Issues #24 and #30 prior to the Board of Environmental Safety’s January 16, 2024 meeting in Ontario, California.


